MEMORANDOM OF UNDERSTANDING

KADIKOY ANATOLIAN IMAM HATIP HIGH SCHOOL ISTANBUL, TURKEY and



ORANGE CRESCENT SCHOOL GARDEN GROVE, CALIFORNIA, USA.

This Memorandum of Understanding Agreement states the terms and conditions of cooperation and collaboration between Kadikoy Anatolian Imam Hatip High School - Istanbul, Turkey and Orange Crescent School - Garden Grove, California, USA who agrees to be bound by this Agreement with the purpose of fostering cooperation, mutual understanding and development in the fields of education and culture. This Memorandum of Understanding is made and entered into on 01.12.2019.

NOW, THEREFORE, In consideration of the mutual agreement made by the parties hereto, the Islamic Cooperation Youth Forum covenant and agree as follows:

- 1. This Memorandum of Understanding Agreement shall start a form of cooperation and collaboration to empower the youth in Muslim community in the United States and all around the world. Also both parties agree to exchange experiences to benefit the Muslim youth around the world.
- 2. Kadikoy Imam Hatip High School will host Orange Crescent School high school students (9thgrade 10th grade) for the annual OIC model on an annual basis. Kadikoy Imam Hatip High School and Orange Crescent School will host annual meetings to increase cooperation and collaboration.
- 3. The two brother schools shall engage in cultural and educational cooperation in fields to be agreed upon. Amendments to the Protocol can be suggested by either party and added at any time by mutual agreement.
- 4. Cooperation may include:
 - a. Joint cultural projects and pilot projects
 - b. Exchange of teaching staff in short terms
 - c. Exchange of students
 - d. Organisation of joint seminars, conferences, workshops and the like
 - e. Exchange of school publications and other materials for cultural and educational purposes
- 5. The following forms of cooperation are envisaged:

- a. Short-term visits of senior members of staff for consultations, lectures and project planning
- b. All the expenses of the brother school will be paid by the school administration of Kadıkoy Imam Hatip High School and the Orange Crescent school will pay all our expenses when we visit their school except for individual expences
- c. Exchange of undergraduate and graduate students for practical training and participation in cultural programmes
- d. Mutual support in the planning and implementation of visits to the respective countries
- 6. Both delegation of the brother schools will be welcomed from the airport and will be assisted to accomadation, food, sightseeing, etc.
- 7. The Brother school's students will be able to get an education at the language schools or any other course in each country with the students exchange.
- 8. Each brother school shall nominate a representative who shall be responsible for the working plans and all matters related to the implementation of the protocol.
- 9. The protocol will be valid for a period of five years, commencing from the date of signing by both parties and automatically renew itself for another five years. This protocol may be terminated with six months prior written notice to the other party, without prejudice to the completion of ongoing projects agreed in the working plans.
- 10. This protocol has been prepared in English and each party will retain one original copy.
